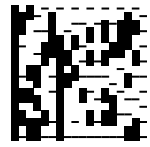

State § 96-18.1 (b), koj lub tuam txhab yuav tsum tau txiav tus neeg ua hauj lwm saum toj no cov nyiaj hauj lwm mus them cov nuj nqis no. Koj tau txais kev ceeb toom txog kev txiav tus neeg ua hauj lwm pob nyiaj hauj lwm los yog kev them nyiaj rov qab uas yuav them, los yog kom them, raws li cov txheej txheem teev hauv qab no.

TSAB NTAUV CEEB TOOM HAIS TIAS lub North Carolina Txoj Cai hais kom koj:

- Txiav kaum feem pua (10%)* ntawm tus neeg ua hauj lwm cov nyiaj them rau txhua lub sij hawm them mus txog thaum tag nrho cov nuj nqis raug them tag nrho lawm. Thov TSIS TXHOB tsocai rau txiav nyiaj ntau tshaj qhov nyiaj tshuav ntawd. Yog tias tus neeg tau nyiaj tam sim no raug txiav nyiaj nyob rau hauv tib seem ntawm Txoj Cai Lij Choj, lub Division xav thov qhov txawv ntawm qhov feem pua txiav tawm, yog kom txog 10%.
- Tshem tawm cov nyiaj tau txiav tam sim ntawd tom qab lub sijhawm them uas tau hais nyob hauv qab no. Thov sau plaub tus lej (4) ntawm tus neeg ua haujlwm tus Social Security naj npawb nrog qhov kev them nyiaj.

Yog koj tsis kam them cov nyiaj haujlwm no yuav ua rau koj muaj feem xyuam rau tag nrho cov lus ceeb toom tib yam nkaus li yog tias tus nqi tau tshwm sim los ntawm koj.
- Lub Division yuav tsum, thaum koj tsis them tus nqi ntawm daim ntawv ceeb toom uas tsis raug tiav tseg raws li N.C. Gen. Stat. § 96-18.1 (d), tawm ib qho kev kuav se tawm tsam koj lub tuam txhab rau qhov nyiaj tshuav tsis tau them ntawm cov nyiaj them tshaj.
